Proizvodnja pasterizovanog mleka, fermentisanih proizvoda od mleka (jogurt, fermentisana pavlaka, fermentisani proizvodi s probiotskim bakterijama, kefir, kiselo mleko), sireva (mlečnih i sirnih namaza, svežih sireva), kajmaka, mleka u prahu pakovanih u PE kese i papirne džakove, PET boce, PS i PP čaše sa Al poklopcima i plastične posude.
